

### 1 ERN Developments

- The 2011 Directive on Patients' Rights in Cross-border Healthcare:
  - o enables patients to be reimbursed for treatment in another EU Member State
  - The Directive became law in EU Member States in 2013 and emphasises the value of
     eHealth and the importance of interoperability in national health IT systems in facilitating

information sharing.

• EU Health Programme:

- o Call for ERNs in 2016
- o The first 24 European Reference Networks started their activities in 2017.

A directive is a legal act adopted by the EU institutions [...], is binding as to the result to be achieved.









## 15 Bridging Grant


- Period: 01.03.2022 31.08.2023 (18 months)

### 1 Introduction to CPMS

- Clinical Patient Management System
- It is a dedicated IT platform to connect ERN members for consultation requests
- Includes a variety of telemedicine tools, such as DICOM viewer
- Developed by Irish IT company OpenApp in 2017
- Provided for free to ERNs by DG SANTE
- Fully GDPR compliant

#### 2 Clinical Patient Management System

- Clinical Patient Management System is the only official ERN patient management tool critical for:
  - o Patient care, diagnosis and treatment
  - Virtual meetings to discuss and prepare outcome
  - o Future clinical research
  - o Collaborative online tools
- The focus is first on diagnosis and treatment for patients by providing tools for collaboration and virtual consultations



#### 3 CPMS Users

- Health professionals defined by Article 3(f) of Directive 2011/24/EU
  - o ERN Members
  - Guest users from the EU and EEA countries\*
- Beneficiaries:
  - o Patients
  - o ERN healthcare professionals
  - o Other healthcare professionals
  - o Researchers



#### 4 CPMS Pathway

- CPMS is a tool designed for and dedicated to consultations between doctors
  - → Patients cannot access the system

- Pathway:
  - o Find ERN PaedCan Member in your country

  - o Establish contact between attending physician and PaedCan representative
  - o Attending physician or PaedCan representative will bring case to CPMS

#### 5 CPMS Expert Groups

- New function of CPMS, currently in Pilot Phase
- Panel discussions for certain disease entities can be directed to predefined
   Expert Groups
- They meet on a regular basis to discuss consultation requests coming in through ERN PaedCan
- Long term goal: have all ECTGs represented as Expert Group in CPMS


## 7 Challenges

 Operation of the CPMS as proposed in 2017 was always hindered by the lack of financial support

• Long established structures in paediatric oncology could not be translated to this new IT tool

• A rigid and difficult platform made it undesirable for medical professionals to use

#### **EUROPEAN REFERENCE NETWORKS**

Helping patients with rare or low-prevalence complex diseases

European Reference Networks' (ERNs) are a European Union's initiative that will make national health systems cooperate in the interest of patients.



The European Reference Network on Paediatric Cancer (ERN PaedCan) will reduce inequalities in childhood cancer survival by providing high-quality, accessible and cost-effective cross-border healthcare to children and adolescents with cancer, regardless to where they live.

#### ERN PaedCan will

- reate a roadmap of healthcare centres that are worldwide renowned for their expertise in treating paediatric malignancies. This network will facilitate the lives of both healthcare providers and of patients whose conditions require specialist expertise and tools not widely available due to low case volumes and a lack of resources.
- implement eHealth technologies and improve interoperability across different institutions (e.g. via a virtual paediatric oncology tumour board network to share expertise and advice).
- ➤ help young patients and their families make informed choices by providing clear information regarding access, quality, safety and reimbursement for treatments received in another EU country.

All this will represent more treatment options and less administrative obstacles for young patients and their families.

#### E PAG's

EURORDIS has developed a European Patient Advocacy Group (ePAG) for each ERN disease grouping. ePAGs

will bring together elected patient representatives and affiliated organisations who will ensure that the

patient voice is heard throughout the ERN development process.



## 2 CCI-E's role & responsabilities

- part of the ERN PaedCan's Oversight Committee
- provides the views of parents and survivors
- involved in the evaluation of the network at regular intervals to ensure transparency and
- contributes to the dissemination of patient information, policy, good practice,
   care pathways and guidelines in close cooperation with SIOPE.
- keep the community up to date and disseminate all important information about and innovations or reforms in the ERN.
- built a sub-network which links between the coordinator of the ERN PaedCan and the national contact points (Patients' and Parents' groups in Europe).
- continue its advocacy activities also within the ERN and will try to represent the Patients' and Parents' voice as effectively as possible.
- contact point for affected children and their families and will incessantly work on being as supportable as possible.

#### **OUTCOMES**

- Up-dated list of CCI-E's national contact points (CCI-E NCP)
- Coordinated bi-monthly ERN PaedCan e-PAG meetings
- Recruitment of a coordinator (contract starting February 2023)
  - ➤ Unique contact point for all 63 CCI-E members in 34 countries
  - Contact and exchange with every single CCI-E NCP
  - > Coordinate the educational efforts (Webinars) among our members
  - Contribution to the implementation of the ESCP's
- Exchanges and discussions about a potential benefits of the Paedcan ERN on European crises such as the Ukrainian war and patient evacuation
